I have worked in the utility business my entire professional life. I have a total of 27 years experience in the industry, most recently with Enstar Natural Gas. Earlier this year I served on the Tri-Borough Mayor's Energy Policy Task Force and co-authored an energy policy report for the Anchorage Chamber of Commerce. In addition, I currently serve on the Advisory Group of the Railbelt Electrical Grid Authority for the Alaska Energy Authority. These experiences lead me to run for the Chugach Board of Directors.

My reason is simple: We need a change and we need to move forward now.

#### Candidate Statement

Significant progress by our reform majority:

- Commissioned a distinguished Blue Ribbon Panel of top executives for an unprecedented review of long-standing Chugach problems. We released their findings and regard them as our roadmap and mandate for action.
- Pressing forward to address long-term solutions to the coming depletion of Cook Inlet natural gas. It's unacceptable to have all our eggs in one basket with 93% reliance on gas-fired generation.
